

If you are interested in bidding on one or more of these sales you must:

1. Complete a Bid Form for the sale(s) you are interested in bidding on and mail it to Fond du Lac Forestry prior to the auction deadline.
*Bids must be received, along with a \$1,000 bid deposit for each sale you're bidding on, before the auction deadline. Make deposit payable to Fond du Lac Forestry.
2. Complete a logger certification form if you have not done so in the past.
3. If your bid is accepted and you are the highest bidder you will be notified by phone or mail. You will have 30 days in which to sign the timber sale contract(s), submit a 25% down payment for each contract, and submit a 15% performance bond for each contract.
4. Prior to operating on the sale you will need to complete a Business License Application, a Tribal Employments Rights (TERO) compliance form, and a W-9 form, each subject to approval, that certifies your eligibility to operate on Fond du Lac timber sales. This license will need to be kept active and current throughout the life of the timber sale contract(s).

Bid Form Instructions

1. On the 2023 Bid Form you will find four tables. There is one table for each advertised timber sale.
2. Under the "My Bid" column, fill in your desired bid amount in dollars per cord for each species listed. A blank box will be interpreted as no bid.
3. Under the "Species Total" column multiply your Bid (\$) by the Volume (Cords) for each species.
4. Calculate your "Total Bid" amount by adding up each "Species Total" and writing the amount in the box provided.
5. After completing the front of the Bid Form you will need to Sign the back page, and write in your business name and address on the lines provided.
6. When finished, fold up the "Bid Form" and return by mail before the deadline. Make Sure to include a \$1,000 deposit for each sale you intend to bid on. Bids without a deposit will not be accepted.
