ABOUT THIS APPLICATION & TRAINING TERMS

The information provided in this application will assist us in determining your initial qualifications to attend this training program. Consent to a pre-selection Drug Screening and reasonable suspicion testing during the training is required. You will not be able to re-test if you fail. You must be physically fit and pass a pre-selection medical screening. A “pay-back” agreement must be signed to be considered for this program. Interviews will be conducted to make final selections.

Be Aware that this is an intensive program and will be conducted in New Brighton, Minnesota. You will be provided a hotel room each week, Sunday through Thursday and will return home each Friday after class. The hotel will provide you with continental breakfast each day. You will be provided with a stipend each week to cover round trip gas money and a small allowance for meals.

Placement after completion is not guaranteed and positions may be in other states. TRAVEL IN THIS CAREER PATH IS REQUIRED - If you are offered a position and decline, this is considered violation of the “pay-back” agreement. If you can't pass a pre-selection drug and medical screening, cannot commit to attending the entire training or if you are unwilling to travel out of state for work, do not apply.
