**Search and rescue efforts are still underway to locate Peter Michael Martin.**

On Wednesday, March 13th, the FDL Police Department, with the assistance of FDL Natural Resources, FDL Conservation, the Minnesota MMIR Office, and local community members, carried out a community search for Peter Michael Martin across 110 acres in the Mahnomen neighborhood of the Fond du Lac Reservation.

Search and rescue operations will continue on Thursday, March 14, and volunteers are still needed to help locate our missing relative, Peter Michael Martin.

Missing Relative Update | March 15, 2024

**Search efforts to locate our missing relative, Peter Michael Martin, suspended for the weekend and will resume on Monday, March 18 at 9am CST.**

The family of Peter Michael Martin requested for search and rescue operations to be suspended over the weekend out of respect and appreciation for all volunteers. No search efforts will occur this weekend. All search and rescue operations will resume from the Brookston Community Center on Monday, March 18th at 9am CST.

Yesterday, Thursday, March 14th, the FDL Police Department, with the help of FDL Natural Resources, FDL Conservation, the Minnesota MMIR Office, FDL Public Works, FDL Behavioral Health, FDL ENP and local community members, continued a community search for Peter Michael Martin across 50 acres in the Mahnomen neighborhood of the Fond du Lac Reservation with a total count of support from 64 persons.

Because of the density of the area searched on Thursday, the search and rescue efforts covered less ground than in previous days. No major findings were discovered, however the Fond du Lac Police Department continues to receive and investigate all Missing Person leads.

Out of respect for the continued efforts to locate our missing relative, Peter Michael Martin, anyone with tips or information related to his whereabouts is asked to call 911, the Fond du Lac Police Department or the St. Louis County Sheriff's Office.

Today's search efforts were focused in Fond du Lac's Mahnomen neighborhood, where the family has provided an account of Peter's last known whereabouts, indicating that his physical location was close to his home.

The Fond du Police Department ensures that all volunteers who assist with efforts are tracked using a mapping system linked to their personal cell phones. Searchers are given detailed instructions on what to do if anything appears out of place, including audibly calling out to inform law enforcement, at which point they will assist and collect any items for further analysis. All volunteers are given broom sticks to help them comb through brush or other terrain during their search efforts.

#### **Missing Relative Update | Monday, March 18**

**Search efforts continue to locate our missing relative, Peter Michael Martin, after 388.9 acres of Fond du Lac's (FDL) Mahnomen neighborhood have been combed through since the search began.**

On Friday, March 15, the family of Peter Michael Martin requested that search and rescue operations be paused over the weekend out of respect and appreciation for all volunteers, and they resumed today, Monday, March 18, at the Brookston Community Center.

Since March, 388.9 acres of Fond du Lac's Mahnomen neighborhood have been searched with the help of community volunteers, FDL Natural Resources, FDL Conservation, the Minnesota MMIR Office, FDL Public Works, FDL Behavioral Health, and FDL ENP until search efforts were suspended for the weekend on Friday, March 15.

On Friday, March 15th, the Fond du Lac Police Department and volunteers were able to search 207.6 acres of terrain, the greatest amount of acreage yet.

The Fond du Lac Police Department ensures that all volunteers who assist with efforts are tracked using a mapping system linked to their personal cell phones. Searchers are given fluorescent yellow vests, whistles, and broom sticks to help them comb through

brush or other terrain. Before beginning volunteer work, all volunteers are given specific instructions on what to do if anything appears out of place, including audibly calling out to law enforcement, at which point they will assist and collect any items for further analysis.

Peter Michael Martin continues to be considered a missing person, and the FDL Police Department is investigating all leads. Anyone with tips or information on our missing relative's whereabouts is asked to call 911, the Fond du Lac Police Department, or the St. Louis County Sheriff's Office.

Search continues for Missing Fond du Lac Relative, Peter Michael Martin

Fond du Lac Band of Lake Superior Chippewa – Cloquet, MN (March 21, 2024) – The Fond du Lac (FDL) tribal community continues to look for missing relative, PETER MICHAEL MARTIN.

Missing relative, 31-year-old Peter Michael Martin, a Fond du Lac Band of Lake Superior Chippewa tribal member who grew up on the FDL Reservation's Mahnomen neighborhood is a father, brother, uncle, friend, 2011 Albrook (Southridge) High School graduate, and an avid basketball player.

On Monday, March 11, officers from the Fond du Lac Police Department (FDLPD) were notified of a missing person and promptly responded to Peter Michael Martin's home in the Mahnomen neighborhood of the FDL Reservation. Officers arrived and were unable to locate Peter at his home. They continued to search the property, its surroundings, and canvassed the neighborhood door to door, but Peter was not found. Soon after, the St. Louis County Rescue Squad (SLCRS) was contacted to assist with the search and provide a mobile command station. Over the next 24 hours, FDLPD and SLCRS launched a 140-acre search and deployed drone support near Peter's home.

On Wednesday, March 13, FDL Emergency Management was contacted, and a community search and rescue effort was launched in the Mahnomen neighborhood, with logistical and investigative support from the FDL Police Department, where Peter was last seen on Friday, March 8.

As of Wednesday, March 20, community volunteers provided over 2500 hours of support and systematically searched, within 10-15 feet of each other, 894 acres of varying terrain, including deep woodlands, fields and wetlands, to help discover and rescue Peter. At this time, search and rescue efforts, as well as an investigation, have not discovered Peter's whereabouts. Peter remains a missing person.

The Fond du Lac Band and FDLPD collaborated with SLCRS and Minnesota's Missing & Murdered Indigenous Relative (MMIR) Office to conduct search efforts. Together they deployed technologies such as drones, airplane surveillance, ATVs, cadaver dogs, human-scent bloodhound dogs, an underwater Remote Operating Vehicle (ROV), an amphibious SHERP vehicle, CalTopo mapping software, and a 21-foot boat equipped with scanning sonar.

**The Fond du Lac Band strengthens efforts to locate missing relative, Peter Michael Martin.**

Fond du Lac Band of Lake Superior Chippewa – Cloquet, Minnesota (March 28, 2024)  
As of Friday, March 22, search and rescue efforts for Peter Michael Martin had been

suspended, due to winter weather conditions and out of respect for the wishes of Peter's family, until the week of April 1st.

Prior to Friday, March 22, over 1000 acres of various terrain in the Mahnomen neighborhood of the Fond du Lac Reservation were searched, with 2500 hours of support from community volunteers, Fond du Lac Police Department (FDLPD) and other agencies.

At this moment, search and rescue operations, as well as investigation efforts, have yielded no results, and Peter remains missing. However, the Fond du Lac Band remains dedicated to assisting the family and locating missing relative, Peter Michael Martin.

On Thursday, March 28, the Fond du Lac Band activated a complete Emergency Operations Center (EOC) process to boost its search for Peter Michael Martin. The Fond du Lac Band's EOC process requires all divisions of the tribal nation to donate all available resources to meet the process's specific needs. With this shift, the Fond du Lac Band expands its capacity to search across the entire Fond du Lac Reservation and surrounding areas of interest, while also enhancing its efforts through the utilization of its staff members' technical skills, knowledge and abilities.
