Technology at FDLOJS

You may already be aware that each classroom in the school is equipped with a SmartBoard that allows teachers to deliver digital instructional content to our students. Research evidence has demonstrated that this method of delivery serves as an aid to increasing student engagement in the material.

Our high school English classes have started using e-readers in the classroom. The e-readers will eventually replace traditional printed material. This digital tool allows students to interact with text in ways not possible in printed material. For instance, if a student encounters a word that they are unfamiliar with all they need to do is highlight the word and the definition appears on the screen. It is hoped that quick-and-easy-to-use reference tools such as this will increase a student's comprehension of the text.

The elementary grade classrooms have begun working to use the tablet computers as an aid to help students practice basic content skills. What's important to note is that by using the tablets in this manner allows our students to spend some of their instructional time honing their individual skills in content areas where

testing data has revealed they may need practice. This method of instruction is aimed at targeting a student's individual learning needs at his or her individual level of skills.

Our plan is to continue to increase the classroom teachers' and students' use of technology for instruction and subsequent learning to the point that it is regarded by both student and teacher as merely another teaching and learning tool no different than chalk and chalkboard. It is our hope that this plan will help our students gain technological soft skills needed in today's digital world.

This summer will see some exciting improvements to the school's website. These improvements will allow the school to easily share more of what's happening at the school with the community. In addition, the website's navigational links will be expanded and simplified so users can gain quick and easy access to the information they are looking for. John Baptiste and Delia (Goslin) Lemieux

Research by Christine Carlson

Wisconsin Historical Collections of 1818-1819 -Agustin Gosselin

Agustin was engaged as a boatman for the American Fur Company at Mackinac in July of 1818. Fond du Lac is noted in the remarks column of this record.

Adelaide Gosselin

Adelaide was the daughter of Augustin Gosselin and Taquasah or Marie Baiaswa Sagimakwe. They were married at St. Anne's at Mackinac on July 17, 1832. Adelaide was born on May 18, 1832 and baptized in Mackinac on July 12, 1832.

Different First Names

I will give a good example of what I have learned about two names. I saw in the records the name Adelaide Gosselin a couple of times. I thought it was a different person and dismissed it. After looking over the research time and time again, I realized that Delia and Adelaide was the same person. The lesson to be learned is to keep an open mind regarding names when you are searching for relatives. You won't want to miss finding a piece of the puzzle.

Ely Diary in the old Village of Fond du Lac - 1837

Men by the last name of McDonald and Goslin were in Fond du Lac in October 15, 1837. They had just arrived from Sandy Lake. On October 19, 1837 Edward and Goslin left for Encampment Island in the morning.

Treaty of 1842

Number 22 of this treaty is the name of claimant Augustin Goslin and the amount of \$169.05 was noted after his name as payment.

Half Breed Script issued on the 1864 Amendments to the

Old Crossing Treaty

Augustine Goslin was given 160 acres which was dated on December 20, 1873.

1888 LaPointe Census

Number 318 is John Lemieux age 60, Delia age 55 and Maggie their daughter 15.

Duluth Tribune of Sept. 2, 1890

John LeMieux will build a three story building 24x75, with stone basement, on lot 6, block 44 Central avenue. A barber shop will occupy the basement, saloon and billiard hall the first floor, and the rest will be used as a hotel. A Rosenberger, an experienced hotel man from St. Paul will run it.

1893 Red Cliff Indian Census

Number 303 is John Lemieux age 65 and Delia his wife age 37.

John Lemieux died in Superior on 12-29-1906 and is buried in Bayfield, Wisconsin

I looked in both the Superior Evening Telegram and the Bayfield newspaper for John's obituary and was unable to find it.

Indian Woman Makes Rugs, Although Blind - Weight of Ninety-two Summers Fails to Keep Her Inactive - Duluth News Tribune 7-23-1916

Although handicapped by total blindness, Mrs. Delia Lemieux an Indian woman of 92 years, continues to weave elaborately-designed and colored rugs while in Superior at the bedside of her sick "children", age 69.

Knots tied into the long strands of colored rags are used by Mrs. Lemieux to measure the quantity of material which must be woven into the rugs. Several of the smaller rugs already have been finished, and although she never will be able to see them, Mrs. Lemieux remarks that "they are nice."

Mrs. Lemieux was born in

a wigwam on the shores of Chequamegon bay in 1824. She has lived in that vicinity ever since. Battles of the great tribes of northern Wisconsin and other sections of the northwest are plainly remembered by the aged woman.

She witnessed a clash between the Sioux Indians and the Chippewas in the early days before the Badger state was recognized as more than a wide expanse of territory infested by the nomadic tribes of redskins. In this battle, Mrs. Lemieux said the Sioux warriors crossed Chequamegon bay and attacked the Chippewa braves in their camp.

The Civil war period is brought to mind by Mrs. Lemieux with a succession of events which happened within the bounds of her tribe. A number of years ago her home was burned and she and her husband John Lemieux, who died in Superior in 1906 moved to Bayfield to live. They lived together for 67 years.

Mrs. Lemieux' maiden name was Miss Delia Goosland. She is the mother of 11 children, most of them still living. She has 29 grand-children and 40 great grandchildren.

While her daughter lies ill in St. Mary's hospital, Mrs. Lemieux will remain with friends in the East End. Peter Lemieux, 506 West Sixth street, is a nephew of the aged woman.

1925 Census for Bad River Chippewa

This 1925 Census shows that Delia LeMieux at age 96 died on 3-7-1925.

"Grandmother" Lemieux Oldest Known Indian, is Dead at Odanah - The Evening Telegram of March 10, 1925

Ashland, Wisconsin - "Grandmother" Delia Lemieux, age 106, and the oldest Indian known, is dead at Odanah.

She was born shortly after the close of the War of 1812 and has lived her entire life on the Odanah reservation. The body will be interred at Bayfield.

The purpose of the lottery is to provide all FDL Band members an opportunity to obtain a recreational land assignment on Big Lake.

Requirements:

- Must be an FDL Band member
- Cannot hold another Recreational Lease
- Must be financially able to carry Lot Rental Fee

Application Procedures:

- Interested Band members should contact the Land Information Department at (218) 878-7143 (Lynn Reynolds) or (218) 878-7128 (Tim Krohn) to obtain an application.
- Eligible applicants will be given a ticket at the time the application is completed.
- This notice will run for two consecutive months in the FDL newspaper.
- Tickets will be drawn at the Land Use Committee Meeting on the last Tuesday of the month following the final notice in the FDL newspaper (April 26).
- Winner of the lottery will be notified and posted in the FDL newspaper.
- Recreational Land Assignment documents will then be prepared by the Land Information Department and submitted to Land Use Committee for approval and then to Tribal Council for approval.
- The term of the Recreational Land Assignment is 10 years, with the option to renew for another 10 years.
- Lot Rental Fee will vary depending on the lot.

WIC Program

Women, Infants, and Children Nutrition Program (WIC) is a nutrition and breastfeeding program that offers tips and advice to help families eat well, learn about nutrition, and stay healthy.

The WIC program provides:

- Nutrition education
- One-on-one counseling about nutrition
- Vouchers to buy food (Range between \$35-\$190/month)
- Support and help with breastfeeding
- Referrals to health care, immunizations, and other programs

Who is WIC for?

- Women who are pregnant, breastfeeding, or who recently had a baby
- Infants from birth to 1 year of age
- Children from 1 year of age to their 5th birthday

To qualify for WIC you need to have a nutritional and/or medical need and meet the WIC income guidelines. All WIC participants must have an initial appointment to determine eligibility for WIC. For example, a family of 3 making \$37,167 or less a year would qualify.

FDL Language Program growth indicators at all district community centers

There are four recent developments that indicate the growth of the Fond du Lac Language Program, with two projects being planned and developed for 2016.

First, the name of the language program has been changed at the request of the Language Advisory Committee and by RESOLUTION #1077/16 of the Reservation Business Committee on March 2, 2016. The new name is Nagaajiwanaang Genawendangig Anishinaabemowin, meaning “the ones who take care of Anishinaabemowin at Fond du Lac.”

Second, the program has a new logo, designed by Mel Diver, winner of the logo contest. The new name and logo will be used on all future publications of the Fond du Lac Language Program. Congratulations, Mel, the logo looks great!

The third development is the establishment in January of Ojibwe language tables at all three community centers. During the first calendar quarter of 2016, language table instructors included Ricky W. DeFoe, Eunice Lightfeather, Ralph Fairbanks, Rick Gresczyk, Dan Jones, and John Daniel, with Carmen Jones also listed as an on-call sub. A strong roster of available language table instructors gives rise to our ability to gather and present a variety of instructional activities and techniques that benefit language table students. All ages are represented at the tables and attendance is increasing. Dr. Fairbanks received a phone call from Brookston Community Center Manager, Bryan Bosto, reporting that the language table in Brookston has strong attendance, and the evening he observed activities, both youngsters and adults were laughing and enjoying a language based inter-

actional game of Ojibwe Trivial Pursuit, created and presented by Eunice Lightfeather.

The fourth development is the ripple effect we are experiencing as we strive to develop cultural and language based activities for the Fond du Lac Community. Interest in events continues to

grow, as shown by the March 19 Traditional Teachings: Winter Storytelling event. Spurred by social media, attendance at the event generated interest at 200% of what was expected; we expected 100 guests, but the actual interest level reached 200 individuals, including groups of children. The plans to add a Sacred Fire to the one-day event drew comments from community members expressing appreciation for the presence of this traditional element of the Anishinaabeg being made available to them. The event was co-sponsored

by Cloquet Community Center, with Manager, Donna Ennis arranging and providing the traditional feast. We are hoping to hold similar events at both the Brookston and Sawyer Community Centers in the future.

The two projects being planned and developed for 2016 are 1) the Summer Language Camp at the Kiwenz Campgrounds at the end of July, and 2) a series of recorded Ojibwe dialogues that will be made into DVD's for language table and community use in learning to speak Ojibwe. An event to show-



Health News

April is Testicular Cancer Awareness Month

Testicular cancer is the most common cancer in American males between the ages of 15 and 35. Testicular cancer accounts for approximately 1% of all cancers in men. Testicular cancer is rare and it usually affects only one testicle. However, it is highly treatable, even when the cancer has spread beyond the testicle. Regular testicular self-examinations can help identify growths early and increase the chances for successful treatment of testicular cancer if identified.

Risk factors for testicular

cancer can include: race, age, an undescended testicle, family history of testicular cancer, HIV infection, abnormal testicle development, personal history of testicular cancer, carcinoma in situ (abnormal cells in the testicle which have not yet progressed to cancer) and body size (some studies suggest taller males are at a greater risk).

The Making of a Salad

Adding more fruits and vegetables to our diet is a great way to improve nutrition. Fruits and vegetables are rich in fiber, vitamins and minerals. They are low in calories and usually fat-free. Eating more fruits and vegetables can reduce the risk for several diseases such as heart disease, cancer, and obesity.

Take every eating opportunity as a chance to increase fruits and vegetables. Eating yogurt? Throw some fruit in it! Having soup for dinner? Add a half a bag of frozen mixed veggies! Need an afternoon snack? How about fresh veggies and dip? These are only a few, simple ways to increase fruits and vegetables daily.

Another way to increase fruits and vegetables is to build your own salad. Below, you will find a list of foods to pick from (complete list is found at eatright.org: Food, Nutrition and Health Tips from the Academy of Nutrition and Dietetics).

Take the list to the grocery store and start shopping. Feel free to choose more than one option and add your favorite if not listed. Don't forget to let the kids pick their favorite items too.

Step 1: Start with the leafy greens. Leafy greens can include:

- Arugula
- Bibb lettuce
- Green or red leaf lettuce

- Iceberg lettuce
- Mixed greens
- Napa cabbage
- Romaine
- Spinach

Step 2: Add the other ingredients:

- Bean sprouts
- Beets
- Bell peppers
- Bok choy
- Broccoli or cauliflower
- Carrots
- Celery
- Corn
- Cucumbers
- Onions
- Peas
- Tomatoes
- Zucchini
- Dried cranberries or raisins
- Apple chunks
- Grapes
- Mandarin oranges
- Strawberries
- Chickpeas
- Edamame
- Navy bean

Step 3: Add a small amount of "the extras" if desired:

- Cheese- cheddar, mozzarella, feta, parmesan
- Nuts- almonds cashews, pecans, walnuts
- Other- avocado, bacon bits, croutons, olives, sunflower seeds

Step 4: If using your salad as a main dish, pick a protein source:

- Beef
- Chicken
- Ham
- Hard-cooked egg
- Salmon
- Shrimp
- Tofu
- Tuna
- Turkey

Step 5: At home, prepare the ingredients by washing, cutting, chopping, peeling, slicing and dicing, as desired. (Don't forget to cook the protein source, as appropriate). Mix all ingredients in a bowl, add a light dressing and gently toss.

Enjoy your salad! Next time be adventurous and try different combinations!

Ma'iinganag Research on the FDL Reservation

The Resource Management Division worked closely with the Minnesota DNR to capture wolves on and around the Fond du Lac Reservation this past winter. The purpose of this effort has been to gather information on the number and movements of local wolves, causes of mortality, and reproduction. DNR biologists use average pack and territory size from collared wolves at FDL and from elsewhere around the State to

estimate the statewide wolf population each year. Resource Management can learn more about how many wolves are using the Reservation, where they travel and what happens to them from this research. The collars we placed on the wolves are programmed to record a location every 4 hours using satellites in the Global Positioning System (GPS) and then transmit the locations back to the biologists. The batteries are expected to last for 88 weeks at which time we plan to remotely break the collars off the wolves so we can

recover them.

Trapping efforts started in early December and lasted through mid-January. Wolves were baited into a location using beaver and deer carcasses, and then snares were set on their travel routes. The snares were fitted with a stop to allow the cable to snug down around the neck, but not tighten too much. Once snares were set, they were checked every morning. We managed to capture and collar 5 wolves in 4 different packs. Once captured, each wolf was sedated, fitted with a collar, ear tagged, weighed, and

measured. Then the sedative was reversed and the wolf got up and ran off. Each workup took about half an hour. Natural Resource technicians Lance Overland, Terry Perrault, and John Goodreau worked closely with two DNR trappers in the effort. Since captures concluded, division staff has been using trail cameras supplemented with observations from a tracking plane to try and get estimates of pack numbers.

Wolf 2505 was our first capture. She was a yearling female that weighed 68 lbs at her capture on Jan. 3. From both

aerial and camera photos she appeared to be traveling with one other wolf. She was part of what is labeled the Ditchbanks Pair in pink on the map. Unlike the collared wolves in the other 3 packs which don't seem to cross major roads very often, wolf 2505 regularly crossed Hwy 73 north of Cromwell. In addition to her regular movements inside her territory, she went south and west of Cromwell and northwest of Prairie Lake a couple of times as well. These looked like exploratory movements as they only lasted a day or two before she turned


around and came back.

Wolf 2505 was also our first mortality of this season. She was found dead on Mar. 15 south of Prairie Lake with 4 feet of broken snare cable around her neck. It had slowly tightened until she choked to death. Coyotes can be taken year round, and it's likely she encountered a snare set for them. The local DNR warden is investigating. Although they are protected from hunting and trapping, research using collared wolves in Minnesota shows that human related factors are still a leading cause of death amongst wolves.

Wolves 2519 (58 lbs at capture) and 2521 (65 lbs) are also yearling females captured on Jan. 8 at the same location. Usually, they travel together and as they are the same age, they are almost

certainly sisters. They are part of the Deadfish Pack shown in orange on the map. From aerial observation and trail camera photos there appear to be 6 wolves in the Deadfish Pack.

Wolf 2517 is another yearling female captured on Jan. 9 weighing 63 lbs. She's a member of the Marshall Pack shown in green. An evening trail camera photo showed 6 members of this pack. Of all of the wolves we're tracking,

the Marshall Pack is the most willing to show themselves at our camera sites during the daylight hours.

The last capture was wolf 2507 on Jan. 16. She appears to be about 2 years old and weighed 71 lbs at capture. She is a member of the Gist Pack shown in blue. Based on track counts, there appear to be at least 5 members of the Gist Pack. Wolf 2507 hadn't ever had puppies when she was

caught, so she's either about to take her turn as the Gist Pack's alpha female or she's likely to strike out on her own and establish a new territory with another wolf or wolves somewhere else. In late February and early March she made two separate movements south of Big Lake Road, across the Cloquet Forestry Center and into the woods between the airport and Moorhead Road. Each trip lasted 2 days before she came

back north of Big Lake Road.

Twin Lakes Drive appears to serve as the clear border between the territories of the Deadfish, Marshall and Gist Packs. Only wolf 2507 from the Gist Pack has crossed Twin Lakes Drive so far, and she's only done it a few times, and for very short periods of time. Other natural and man-made features such as Hwy 2 and 210 and the St. Louis River are also pretty clear territory boundar-

ies. So far there's been very little trespassing by the collared wolves into one another's territory. In addition to the packs where we have collared animals, there are other wolves out there too using the Reservation. The Cloquet Forestry Center has video of at least a pair of wolves using their property who don't appear to be part of a collared pack. Other wolf signs are regularly noted north of Hwy 2 and along the river near Brookston.

Wolf numbers are at about their lowest in mid-winter, but their numbers will roughly double when pups are born in April. The alpha females will start using the den sites beginning in late March. The Resource Management Division will continue with the tracking and monitoring of Fond du Lac's wolves for as long as we can to learn more about where they go and what happens to them. Our tentative plans are to try and replace any lost collars with new ones if necessary in the same packs next winter or next summer or try to collar wolves from new areas.

of her life and she raised her to value choice and education. She celebrated her daughter's successes and those of her son-in-law, Richard, whom she held in great affection. She took great joy in the companionship of her Yorkshire terrier, Bailey, who remained by her side until her last day.
