

A procession led by the women from the Minnesota Indian Women's Sexual Assault Coalition of St. Paul and the Sacred Hoop Coalition from Duluth honor survivors of physical and Sexual Violence in Native American Communities at this weekend's Mashkawisen Sobriety Powwow. Both groups are working to end such violence in Native American community and take the shawls and arm bands to powwows to raise awareness about the high rates of sexual assault and domestic violence perpetrated against Native people. The fringe on the shawls is said to represent the tears of Indian women crying for the pain and suffering people have endured for generations: vet it also represents strength, beauty and solidarity. The arm bands are to honor the men who have also survived violence. People place their donations in the red shawl being carried in the front of the procession.

# A few thoughts from RBC members

#### From the Chairwoman

he Band announced its intention to pursue Class I air quality designation for the Reservation. Class I is

the same standard used for national parks. Class I air quality will protect Band lands on the Reservation from new, major sources of air pollution. It will not affect current sources unless they have major expansions. Protect-


ing the Band's air quality goes hand-in-hand with our protection of water quality. If you can keep pollutants out of the air, you can prevent them from falling to the ground and getting into water.

This is the beginning of the process to seek this designation from the Environmental Protection Agency. There is a lengthy public comment period, informational meetings, and notifications of surrounding jurisdictions that must occur. There are currently some indications that surrounding jurisdictions may be inter-

preting this as an attempt by the Band to limit mining activities in the ceded territories. Hopefully with further information, it will be understood that this designation is for land within the

> borders of the Reservation. The Fond du Lac Environmental webpage has more information for those that are interested, as well as the upcoming informational meetings.

The Band has been the recipient of several grants to increase the community's access to high speed internet and greater technology use. Thanks to the Blandin Foundation, the Band

has installed wireless capabilities on public buildings, with a range of a ¼ to a ½ mile. The Ojibwe School has an App Camp, teaching youth how to create their own computer apps. This is complimentary to efforts to bring I pads into the school. The Band is currently seeking funding to expand fiber optic internet access to homes on the Reservation. We will continue to work on connecting the Reservation to the internet.

In closing, I will briefly touch on the remarks in last month's column by Representative Kevin Dupuis. I will show him the courtesy and respect of his office, even though that same courtesy was not extended to President Norman Deschampe or me. While Representative Dupuis is entitled to his opinion, his opinion was obviously not shared by even one member of the MCT Tribal Executive Committee since they dismissed the allegation unanimously without any discussion. I am saddened that ongoing efforts to disrupt governance take so much time and effort away

#### From the Secretary/ Treasurer

Boozhoo,

hope your summer is going fine. It has been a pretty good summer here on the Res. We have managed to be able to pick a few berries even with the late spring. The season will be the wild rice

harvest. It is looking very good for the harvesters this season. There should be a good crop of rice even with the shorter growing season this year. We made a change in the per cap plan this year. For the past several years we were able to

> fund the payment without using our gaming revenues. We were able to fund it with other income sources and interest returns on the investments. This year we are not able to cover the entire plan with other sources so we had

to do a gaming revenue allocation plan and submit it for approval to the Secretary of Interior. It was submitted last week so we can still implement the payment on January 1, 2015. The plan that was submitted will not change your monthly amount. Once we receive approval, a copy of the plan will be available.

We are also going to a new payment card so make sure that your address information is correct with the per cap office. I received a list that had approximately 90 names that did not have a current address so we will not be able to send a new card to you.

There are some changes in the scholarship program that could mean more funding for the students so check with the scholarship office if you have not already been made aware of the changes and how they could affect you

The last thing that I would like to mention this month is rather difficult to write about. I do realize that not everybody agrees with me and how I do the job I currently hold but I try to do my best as do all other members of the RBC. I respect that and most of the time, welcome the discussion that is sparked from it. I can't speak for the rest of my colleagues but I work for you and am willing to do what I can to see that you get what you are asking for. I will not say that I am always successful in my attempt but it is brought forward and discussed on how

we can help within the established guidelines. If the decision is "NO", it is because we have all said no. Our rice lakes are looking great, there should be a great harvest season. For the members that rice, I hope you have a good and safe harvest. This season there was a change in the ricing procedures. The RBC passed that NON-INDIAN spouses can rice with their FDL

spouse. With the condition that they have a state ricing license and FDL permit.

Our last open meeting was held Aug. 21, at the MCT building in Minneapolis. There were about 30 people there in attendance. The meeting didn't last long and it was adjourned. There was


several issues that came up. I would like to say a few words on these issues.

The first issue in the open meeting the chairwoman made a statement pertaining to the pipeline negotiations. The statement was, that the negotiations were about the bog on and off the Reservation. When I was elected the information presented to me by the RBC and during the last negotiation with Enbridge in no way, shape, or form was this information given to me. The information that was given to me was that RBC agreed to a sum of 18 million dollars as a onetime payment, with a 20 year contract. The upper Dead Fish impoundment is directly below the pipeline if there where accident at that section of pipe, that would go into the

impoundment and then into Dead Fish Lake. It is our obligation to protect the land and our way of life.

The second issue is the casino loan was brought up. The statement that the chairwoman made was that the bottom fell out and the RBC tried to refinance the loan but the interest rates were too high. The concern I have with that is that individual RBC members have stated in past articles in our paper that they had to pay off the loan due to a balloon payment. Yes there was a balloon pay-

ment if you wanted to pay that off in that manner. There were other options that were or could have been done with that loan. First, any change to the loan would have to be done by resolution from either party. To establish the Band's intentions if we were to refinance, find another financial institution, maintain the



Recently the TEC approved an ordinance (Ordinance Implementing Constitutional Petition And Censure Process). This ordinance should have been brought forward to the membership.

The Brookston community meetings will be Sept. 17, Oct. 15, Nov. 12, and Dec. 17.

promotion. This attracted a record number of guests for that event. The staff at the Black Bear all worked hard and handled it well. An upcoming event featuring the singer, Gary Allen, is scheduled for September. The tickets for this event sold out the very first day. This is good news and will be a big event for our customers.

Our Fond du Luth Casino has been approved to have an architect firm draw up some preliminary plans for some remodeling projects at this site. The ultimate project go ahead has not hap-

#### Colville Strike team

he cold snowy winter transitioned into a cold wet spring. The wildfire season was the slowest in 50 years for the state of Minnesota. Meanwhile, on the news we hear about the California drought. The drought isn't confined to California. Other western states are experiencing the effects of drought.

Wild land firefighters are deployed nationwide to regions where they are needed. So, far Fond du Lac has sent firefighters to Arizona, Washington, and Idaho.

Aug. 16, an Engine Strike team from multiple Reservations was dispatched to Colville Reservation in North East Washington. The engines sent include:

- Fond du Lac Engine 0561 with Engine Boss Matt Goseyun, Firefighter Matt Weske and Fighter Josh Whitebird
- White Earth Engine 0861 with

Engine Boss Jeremy Londo, Firefighter Steve LaFrinierer Ir

- White Earth Engine 0861 with Engine Boss Terry Snetsinger, Firefighter Jerrett Nelson (Red Lake) and Firefighter Lance Northbird (Fond du Lac).
- Leech Lake Engine LL2 with Engine Boss Duane Bebeau, Firefighter James Tejohn, Firefighter George Jacobs
- Red Lake Engine 0962 with Engine Boss Gil Juarez, Firefighter Mike Seki, and Firefighter Lance Crowe. Strike Team Leader, Steve Olson and Strike Team Leader trainee Steve LaFrinierer Colville Reservation's fire season began 2 months early in May. Severe drought conditions continued into the summer. Prior to the call for the strike team, Colville had a large fire, the Devil's Elbow, this fire was turned over to an incident

management team so the Reservation firefighters could concentrate on new fires. The Colville's firefighters were being run ragged so the call was made for additional

resources.

sota Agency and the Red Lake Agency were able to answer the call with the Minnesota Strike Team.

The Devil's Elbow fire was

when the MN Strike left and grew to 26,000 + acres by the time the team arrived at Colville. The first day the strike team was put to work assisting with initial attack on the 173 acre Smoke Ranch fire. The strike team has assisted with

9.900 acres

initial attack on four additional fires and helped monitor other fires.

In the past Minnesota Reservations have sent similar strike

teams to other Reservations across the country such as: Ute Mountain, Oklahoma, Blackfeet, Pine Ridge, and Crow Agency. In return Minnesota Reservations have received assistance from Eagle Butte, Blackfeet, Cheyenne River, Wind River and Kewana Bay. These exchanges not only help the receiving agencies in their time of need but also create friendships with fellow firefighters.

Other off unit fire dispatches include: Matt Goseyun to Pima Agency as Engine Boss, Matt Goseyun, as a sawyer, and Lance Northbird, as a fire-fighter to Chiwakum Complex (WA) on Minnesota #1 twenty person crew, and Cody Bauer as a firefighter on Minnesota #3 20 person crew to Idaho.

# Protecting our environment

On July 23, the Fond du Lac Band sent a letter of intent to the Environmental Protection Agency notifying the agency that the Band intends to pursue Class I air quality re-designation on the Reservation.

Class I status means that pollution from new, major sources will be more limited than what is allowed in most other areas of the country, which are known as Class II areas. Major sources can include power plants, petroleum refineries, and Kraft paper mills.

The State of Minnesota already has two other Class I areas – the Boundary Waters Canoe and Wilderness Area and Voyageur's National Park. Other regional Class I areas include Isle Royale in Michigan and the Rainbow Lakes Wilderness Area in Wisconsin. National parks, forests, and

monuments (like the areas listed above) were designated "Class I" by Congress, and all other areas of the country were designated "Class II". States and tribes have the right to re-designate their Class II lands as they see fit. So far, five other tribes in the US have requested, and received, Class I re-designation. No state designated Class I areas exist.

Chairwoman Karen Diver stated "Class I status will allow the Band to protect our Reservation's air quality for generations to come. The Band will be able to have a place at the table in reviewing permits for new sources and broaden our stewardship on environmental issues."

#### Contract Health Services descendent eligibility

Because of its trust responsibilities to provide health care to American Indians, the federal government included several provisions in the Affordable Care Act that are American Indian specific. One of these provisions is the ability for American Indians enrolled in a federally recognized tribe to enroll in a qualified health plan (OHP) at any time throughout the year. This provision does not apply to descendents of American Indians enrolled in a federally recognized tribe.

Descendents are only able to enroll in a QHP during the open enrollment period. For the coverage year of January 1, 2014 through December 31, 2014, the open enrollment period ended March 31, 2014.

Any descendent who does not enroll in coverage, either public or private, may face a tax penalty (Shared Responsibility Payment), and may risk their Contract Health Services eligibility.

For decades, Contract Health Services has served as a payer of last resort. With the new methods of securing private insurance at no cost to Indian patients, Contract Health Services dollars will only be used for those individuals who comply with all of the rules related to acquiring health insurance coverage. This includes completing the application process for public and private medical insurance through MNsure, Minnesota's new Health Insurance Marketplace.

Because of the confusion surrounding the ACA in general, and the lack of American Indian specific outreach and education, Contract Health Services eligibility for descendents will not be affected by non-enrollment in a QHP for the 2014 coverage year. The Open enrollment period for 2015 coverage begins November 15, 2014 through February 15, 2015. Descendents who do not complete the application process during this time will not be eligible for Contract Health Services beginning January 1, 2015. Please keep in mind that individuals must apply for Medicaid and MinnesotaCare at any time throughout the year to determine eligibility.

To ensure you and your family's CHS eligibility, please stop in to Min No Aya Win or CAIR to see a FDL Patient Advocate or call them at (218) 878-2165.

"Protect Your Groundwater" Day was designated by the National Groundwater Association to help promote water conservation and contamination prevention awareness. We can all do our part to protect our groundwater by simply maintaining our septic systems. When septic systems fail harmful bacteria, waterborne diseases, and nitrates could enter the local groundwater supply and have serious adverse health effects. Septic systems cannot treat and dispose of wastewater from kitchens, bathrooms, and laundry rooms if they are improperly used. Cooking grease, coffee grounds, citrus rinds, or egg shells do not break down and can cause your septic system to fail. Excessive detergents and harsh cleaners can wreck the microbes that break down waste. Dispose of waste properly by making sure things that could go to the trash do and not down the drain. Remember it is up to the private homeowner to maintain their septic systems. Having your system inspected annually, and pumped if you rely on a septic tank is the best way to avoid replacing failed systems are costly and harmful to our groundwater supply.

ary Dubreiul's Family -1880 Census for Superior, Wisconsin Louis Dubreiul is listed as a 54 year old farmer born in Canada. He is married to Pollie age 37 who was born in Minnesota. Their children are Mary age 17, Lizzie age 15, Louis age 13, Caroline age 11, Josephine age 9, Joseph age 7, Sophia age 5, Julia age 3, and Claude age 1. They were all born in Wisconsin.

Mary's mother is also known as Paula Obikwad and or Polly Mishakikamigokwe.

#### Notice of Sheriff's Sale in Carlton County – Duluth Daily News of January 21, 1882

This Sheriff's Sale is another source of information that I have not used before. This sale is printed in the newspaper and it involved a lot of land in Carlton County. This notice describes in detail the lands in question in both Moose Lake and Thomson. Listed are two different plaintiffs against the defendant Frank Duquette. The order was signed by Sheriff Hugh Ferguson and the plaintiff's attorneys.

#### **Mary Dubrie Assaulted**

In the Fall of 1883 there was a court case involving Mary Dubrie who was assaulted by a non Indian in the old village of Fond du Lac. The perpetrator was a wealthy Fond du Lac man and was found not guilty. Court cases are another resource of valuable information. You need to find the date and county involved and

whether it is a civil or criminal case.

# 1885 Minnesota Territorial Census for Twin Lakes,

Family Number 81 is Louis DuBray age 54 from Canada. His wife is Polly DuBray age 42 from Minnesota. Their children were all born in Wisconsin and they are Mary DuBray age 23, Lizzie DuBray age 21, Louis Jr. age 18, Kate DuBray age 16, Susette DuBray age 14, Jo DuBray age 12, Sofia Dubray age 10, Julius DuBray age 8, Wm. DuBray age 6, and Ben DuBray age 1.

#### 1888 Fond du Lac Indian Census

Family number 342 was an Irishman who was 29 years old. His wife was Mary Du-Bras age 25. Their 3 sons are age 7, 5 and 2. There are no names that were listed only that they were all boys.

#### 1891 Fond du Lac Indian Census

Family number 715 is Mrs. Mary Dubreiul Dukette aged 28 and her un-named son age 9.

# Frank Duquette Jr.'s Parents - Frank Duquette Sr. and Sarah Rouillard and the town of Duquette, Minn.

The town of Duquette in Pine County is named after this Duquette family. In 1865 Frank Sr. worked on the Military Road in Superior, Wisc. I am working on another story about this family.

#### 1895 Minnesota Territorial Census for the old Village of Fond du Lac

Family number 405 is Frank

Duquette age 31 and his occupation was running a hotel. His wife is listed as Mary age 32 and her younger sister Kate Dubray age 26 was living with them.

# Fond du Lac Brevities at the Old Fond du Lac Village in Western Duluth – Duluth News Tribune of Feb. 24, 1896

Frank Duquette, the all around hunter and trapper, has just returned from a fishing trip to Lake Sawyer. He brings a nice string of pickerel as fruits of his trip. (I am thinking Lake Sawyer is now Big Lake).

#### Flooding in the Old Village of Fond du Lac – April 17, 1896

I grew up in this old village of Fond du Lac. The Carlson family lived next to Mission Creek on Paul Avenue. On June 30, 1958, there was a big flood in the town so I know what devastation these floods can cause. Way back in April of 1896, there was also a flood. The Frank and Mary Duquette family who lived by the St. Louis River lost their dwelling and a portion of the contents to this devastating flood.

## 1900 United States Census from Moose Lake, Minn.

Frank Duquette age 35 is listed as a farmer and day laborer. His wife is Mary age 38 and their son is Jerome age 1 year. Also listed with the family is Kate Erickson age 31 and

her daughter Mable age 1.

#### Mrs. Mary Duquette Dies at Indian Hospital – Pine Knot of Feb. 26, 1926

Mrs. Mary Duquette of Moose Lake, died at the Indian Government hospital west of this city last Friday, Feb. 19. Mrs. Duquette was about 63 years of age. She had been a patient at the hospital for two months. She leaves a son, in Cloquet and three sisters living at Fond du Lac, Minn. The body was taken to Moose Lake in the spring.

#### Death Register of Mary Duquette – of Carlton County in 1926

Mary's date of birth was Jan. 7, 1863 and she died of Chronic Interstitial Nephritis and Diabetes Mellitus on Feb. 19, 1926. Mary's father was listed as Louie DuBry and mother's name was listed as unknown.

Frank Duquette Jr. is buried next to his father and mother in the Duquette Cemetery in Pine County.

## Story as Teaching Tool – Legal Documents

I am so glad this story has progressed into a teaching tool. I have not discussed much about estates and in Frank Duquette's file I had the estate orders that I found in the newspaper. In the Pine Knot of March 30, 1916 are the two estate orders that were published after the death of Frank Duquette Jr. These legal documents are: Order Limiting Time to File Claims and for Hearing Thereon and Citation for Hearing on Petition to Sell, Mortgage or Lease Land. These documents give more information to piece the puzzle of your ancestors together.

# Health News

#### Processed meats and cancer

ccording to research, regularly eating processed meats increases the risk of cancer, specifically colorectal cancer. What are processed meats? The American Institute for Cancer Research defines processed meat as "meat preserved by smoking, curing or salting, or the addition of chemical preservatives." Processed meats include sausage, bacon, deli meats, hot dogs, ham, pepperoni, salami and corned beef

It is not yet clear why processed meats increase cancer risk but two areas experts are researching are: nitrates/nitrites added to meats to preserve color and prevent spoiling form cancer causing compounds; and, smoking meat. This process produces substances PAHs (Polycyclic Aromatic

Hydrocarbons) that are formed at highheat and are considered carcinogenic.

Often, high intake of processed meat goes hand and hand with other unhealthy behaviors such as smoking, inactivity, and low intake of fruits and vegetables. The occasional hot dog or slice of bacon will likely not increase the cancer risk. Consistently consuming processed meats is more concerning. To reduce your risks consider these tips from the AICR:

- Replace packaged deli meats with fresh chicken or fish
- Instead of bacon or salami, try spicy vegetarian sausages
- Replace sausage in chili and sauces with kidney beans, chickpeas, and lentils
- Try different sources of protein like eggs, cottage cheese, hummus, and other beans
- Cook meats using methods that use

a lower temperatures such as baking and poaching

• Use herbs and spices to add flavor to your dish

Here are some tips from the American Cancer Society on adding flavor to your food:

#### Biomonitoring Study update – first community report available

The FDL Human Services
Division management recently

approved a 10-page report that describes results for the three heavy metals—cadmium, lead, and mercury—that were tested for in blood samples collected for the FDL Community Biomonitoring Study. Last March, personal results for cadmium, lead, and mercury were sent to everyone who took part in the study. As these are the only 3 chemicals for which all testing is completed, study staff has decided to share the results that are available at this time with the whole community.

As expected, cadmium, lead, and mercury were found in participants' blood samples since most people are regularly exposed to small amounts of these chemicals. These results can be interpreted by comparing them to results from other biomonitoring studies, such as First

Nations data collected in 2010-2012 from 13 Canadian communities and U.S. general population data collected in 2009-2010. Results can also be compared to a precautionary value called a Level of Health Concern. Some people may be affected by an amount of a chemical that is above the Level of Health Concern, while amounts that are below are less likely to cause harm to a person's health.

Most people in the FDL study had less cadmium, lead and mercury than the First Nations study participants and also less lead and mercury than the U.S. general population.

Smoking is a major source of cadmium and had a large effect on cadmium results. The FDL study participants had more cadmium compared to the U.S. population, most like-

ly because the smoking rate was also higher. All people whose cadmium results were above the Level of Concern were either current or former smokers.

Only three people had a lead result above the Level of Health Concern. Two of these were likely due to on-the-job exposures.

Mercury results for all study participants were below the Level of Health Concern.

### Ashkaanimin Biininesewin – Let Us Breathe Clean Air

¬he Fond du Lac Band has taken the first steps in a process that will protect air quality on the Reservation for generations to come. The Band recently began the public process to reclassify its Reservation air quality from Class II to Class I. Class I is a designation that has been traditionally enjoyed only by national forests, parks, and wilderness areas, like the Boundary Waters Canoe and Wilderness Area and Voyageur's National Park. However, the Clean Air Act also affords this protection to tribes and states as a means to protect their air quality as well. This increase in protection will aide in ensuring that the current quality of air is enjoyed for many years to come. This protective status will greatly benefit the health of Reservation residents, flora and fauna living on and near the Reservation. This protection is accomplished by reducing the amounts of harmful criteria pollutants that can be absorbed, inhaled or ingested.

Class I air status will limit the amount of air pollution that can come from new and/or modified, "major sources" of air pollution. No existing facilities will be impacted unless they undergo a "major" expansion. "Major sources" and "major expansions" are those whose air emissions are expected to be above certain levels, or thresholds. Typical types of "major sources" are chemical plants, coal-

fired power plants, or refineries.

The Class I process will include a public hearing (to be held at Black Bear Resort and Casino) on Oct. 2 from 3-9 p.m. Public comments will be taken until Oct. 13. The Band has also offered consultation to various state, local, tribal and federal governmental agencies that might be affected. Upon completion of this, the United States Environmental Protection Agency, who oversees this process, will begin their review work. The EPA will hold another public hearing and comment period.

The Resource Management Division is committed to the management, conservation, and sustainability of the natural resources of the Fond du Lac Band in order to protect the environment on the Fond du Lac Reservation and within its treaty areas. The Resource Management Division will use the tools of research, education and outreach with Band Members, partners and stakeholders to accomplish these goals. The Division is proud to be entrusted with protecting Reservation resources and wants to hear your comments about this process. #### Smile for you


Smiling is infectious; you can catch it like the flu. When someone smiled at me today, I started smiling too. I passed
